New Text Message

Along with many other great features our new debit cards have brought us comes Fraud Alert Text Messages. Our fraud company will send you a text message asking whether a transaction is one you made and you can simply reply yes or no. Replying yes will allow the transaction to go through and keep your card active, while replying no will turn your card off and block the transaction in question. They will also try to call and email if they can't get a reply by text message.

** SecurLock Equip App **

With warmer weather comes the time for travel and vacation! One of the features of our new debit cards is an app called SecurLock Equip. This app allows you to monitor your card's usage by being notified when your card has been used. You can also turn off your card if you misplace or lose it and turn it back on if you find it. Another great feature is that you can set your own travel notices! You no longer have to worry about calling us to let us know you are going out of state; you can either let the app follow your location so it will know you are where your card is being used, or set zip codes and areas where you will be traveling. If the app denies a transaction you are trying to make, it will allow you to approve it and try again.
